Obligations of the Applicant and License

1. An applicant must pay a license fee of \$25.00 and a permit fee of \$10.00 for each solicitor.
2. A permit issued to a solicitor is not transferable and shall be carried with the solicitor while he or she is engaged in the business of soliciting.
3. A license and identification badge shall be used only by the person to whom they were issued.
4. Solicitations are allowed only between the hours of 9:00 a.m. and 8:00 p.m.
5. No solicitor shall engage in solicitation activities regulated under this chapter on city property without first procuring special authorization from the chief of police or his/her designee.
6. No person shall engage in business as a solicitor in defiance of any notice exhibited by a residence or business indicating that solicitors are not welcome or not invited.
7. This License can be suspended, revoked and/or denied.
8. A person who violates any provision of the Ordinance 462-95 can be fined up to \$500.00 per violation. Each incident can be a separate violation.
9. Each solicitor under this applicant must complete the one page attachment to this application.
