On or about 3/2/21, the City of Hallettsville will submit a request to the Texas General Land Office (GLO) for the release of Community Development Block Grant Disaster Recovery (CDBG-DR) funds under Section 104(f) of Title I of the Housing and Community Development Act of 1974 as amended, to undertake a project known as 2017 GLO DR Flood and Drainage Improvements under GLO Contract #20-065-036-C116 for the purpose of improving the conveyance of storm water on S. Dowling Street, to prevent future flooding. Estimated grant funding and total project cost is \$279,939.00.

**Project Description:** S. Dowling Street is in a state of degradation as erosion has continued since the flooding caused by Hurricane Harvey. The city was unable to assist residents during the storm due to high water levels that prevented emergency responders from accessing this neighborhood. The proposed drainage improvements will prevent flooding of the streets during rain events by increasing the drainage system capacity.

Subrecipient shall regrade 1668 LF of roadside ditches, install seven (7) culvert crossings, and complete associated appurtenances. All work will be done in the ROW. Acquisition is not required.

The activities proposed are categorically excluded under HUD regulations at 24 CFR Part 58 from National Environmental Policy Act (NEPA). ## **ENVIRONMENTAL CERTIFICATION**

The City of Hallettsville certifies to the Texas General Land Office that Alice Jo Summers, in her capacity as Mayor, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. The Texas General Land Office's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of Hallettsville to use Program funds.

## **OBJECTIONS TO RELEASE OF FUNDS**

The Texas General Land Office will accept objections to its release of funds and the City of Hallettsville's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request, (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Hallettsville; (b) the City of Hallettsville has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by the Texas General Land Office; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the Texas General Land Office, P. O.
