They are typically on the front end of the unit facing the front driveway. The porches are included in the park model dimensions. The porches will meet the setback requirements.
 - V5 REQUEST A Variance for all manufactured homes to have a 4' X 4' porch and steps/ramp in the rear building setbacks. The homes all have rear doors and all will be elevated above the ground, as all MHS are due to their understructure and crawl space.
