Check GUILTY or NO CONTEST on the REPLY FORM (other side #1). Mail the completed REPLY FORM and payment by Cashier's Check or Money Order made payable to City of Hallettsville postmarked by the appearance date noted on your ticket. You may pay with credit card by calling 361-798-3681.

Check GUILTY or NO CONTEST on the REPLY FORM (other side #3). Mail the completed REPLY FORM to the court. Your amount due MUST be paid within 30 days to avoid late fees. (If mailing, MUST be postmarked within 30 days).

To be eligible you MUST do ALL of the following: Complete the DRIVING SAFETY COURSE AFFIDAVIT (other side #2) and have NOTARIZED. Mail AFFIDAVIT, Proof of Insurance, Copy of Driver's License and a Cashier's Check or Money Order for \$144.00 (\$169.00 if in school zone). ALL ITEMS MUST BE POSTMARKED BY YOUR APPEARANCE DATE THAT IS NOTED ON CITATION.

You MUST send completed REPLY FORM (other side #2), noting NOT GUILTY plea and desired JUDGE or JURY TRIAL and a copy of Driver's License. You will be notified by mail of trial date - you MUST notify the Court if your address changes.
