SPECIFICATION TO FURNISH GASOLINE AND DIESEL FUEL TO THE CITY OF HALLETTSVILLE FOR THE PERIOD OF JANUARY 1, 2025 TO DECEMBER 31, 2025

The City of Hallettsville will be accepting bids for the purchase of gasoline and diesel fuel for the City of Hallettsville Public Works, City of Hallettsville Pole Yard, and the City of Hallettsville Park/Golf Depts. for the period beginning January 1, 2025 and ending December 31, 2025.

- 1. Fuel shall be bid on delivered basis to each location. Bidder shall deliver fuel within 24 hours or sooner after receiving the order (excluding weekends and holidays).
- 2. Diesel fuel shall be Ultra-Low or Dyed Diesel and shall be of quality for use in trucks, tractors, equipment, and mowers.
- 3. Gasoline shall be Unleaded Regular and have a minimum octane rating of 87.
- 4. Gasoline shall not contain more than 10% or whatever maybe required for this area of alcohol, gasohol, methanol additives, substitute or blends. Fuel, gasoline or diesel shall not be contaminated with any foreign matter or impurities such as water, dirt, trash, etc. Bidder will be disqualified as a supplier to the City of Hallettsville if any of the above additives are found.
- 5. The Contractor to whom the bid is awarded must label all fuel tanks and supply the City with material safety data sheets.
- 6. Bids should include State Taxes (stated separately) for gasoline and ULS diesel fuel, and exclude taxes for dyed diesel fuel.
- 7. Prices for fuel delivered to our tanks located as follows:
 - City of Hallettsville Pole Yard, 725 S. Promenade, Hallettsville, Texas 77964 400 gallons dyed diesel per order
 - City of Hallettsville Park/Golf, City Golf Course, Hallettsville, Texas 77964 300 gallons dyed diesel per order
- 8. Gasoline delivered to City of Hallettsville Public Works Dept. at 401 E. Second St. Hallettsville, Texas 77964, shall include bidder to furnish a 1,000 gallon tank for gasoline including secondary containment, pump, meter, hoses, and automatic shut-off nozzle.

- 9. Diesel fuel delivered to City of Hallettsville Public Works Dept. at 401 E. Second St. Hallettsville, Texas 77964, shall include bidder to furnish a 300 gallon tank for ULS diesel, secondary containment wall, pump, meter, hoses, and auto shut-off nozzle.
- 10. Bids are to be quoted to the nearest one-one hundredth (1/100th) of a cent per gallon above the refiners posted terminal price. Bid must be a firm, specified state exact amount, with no escalated bid amount being acceptable. Please state the refiners posted terminal price for the following between the following dates: November 1st thru 8th, 2024. Terminal price printout must be attached to bid.
- 11. The terminal price will change through the year, but tax on gasoline and your mark-up is firm and cannot change during the 2025 contract year (1/01/2025 12/31/2025)
- 12. Bidder must complete the enclosed Statement of Statutory Compliance, Texas Senate Bill 252 Certification, and the Conflict of Interest Questionnaire and return the forms along with the bid packet. Upon City Council awarding a bid, the winning bidder will be required to complete the Form 1295 online.
- 13. The City of Hallettsville reserves the right to extend this contract for an additional 90 days if agreeable between the bidder and The City for the quoted prices.
- 14. The bidder or a representative may be present at the opening to answer questions pertaining to their bid.
- 15. The City of Hallettsville reserves the right to accept or reject any and all proposals, to waive informalities, and to award the contract to the bidder who, in the opinion of the City Council, offers the proposal to the best interest of the City.

A complete copy of Chapter 176 of the Local Government Code may be found at http://www.statutes.legis.state.tx.us/ Docs/LG/htm/LG 176.htm. For easy reference, below are some of the sections cited on this form.

Local Government Code § 176,001(1-a): "Business relationship" means a connection between two or more parties based on commercial activity of one of the parties. The term does not include a connection based on:

(A) a transaction that is subject to rate or fee regulation by a federal, state, or local governmental entity or an agency of a federal, state, or local governmental entity;

(B) a transaction conducted at a price and subject to terms available to the public; or

(C) a purchase or lease of goods or services from a person that is chartered by a state or federal agency and that is subject to regular examination by, and reporting to, that agency.

Local Government Code § 176.003(a)(2)(A) and (B):

- (a) A local government officer shall file a conflicts disclosure statement with respect to a vendor if:
 - (2) the vendor:
 - (A) has an employment or other business relationship with the local government officer or a family member of the officer that results in the officer or family member receiving taxable income, other than investment income, that exceeds \$2,500 during the 12-month period preceding the date that the officer becomes aware that
 - (i) a contract between the local governmental entity and vendor has been executed;
 - (ii) the local governmental entity is considering entering into a contract with the
 - (B) has given to the local government officer or a family member of the officer one or more gifts that have an aggregate value of more than \$100 in the 12-month period preceding the date the officer becomes aware that:

 - (2) the date the vendor becomes aware:
 - (A) of an employment or other business relationship with a local government officer, or a family member of the officer, described by Subsection (a);
 - (B) that the vendor has given one or more gifts described by Subsection (a); or
 - (C) of a family relationship with a local government officer.
