### CONTRACTOR LICENSE

General Contractors doing work within City Limits are required to obtain a Contractor's License. Before a contractor license may be issued or renewed, the contractor must provide The City with a copy of a current bond in the amount of \$5000, made payable to the City of Hallettsville. The Contractor's License fee is \$100, and is valid for 12 months. The license can be renewed **within** 12 months for \$50, or **after** 12 months for \$100. All electrical, mechanical, and plumbing contractors performing work within City Limits must be licensed by the State of Texas. The City does not require state licensed contractors to obtain a separate City License.

### PLANS
